Proposed Amendment

Based upon the current laundry industry, this is a very new concept, as usually hospitals are offering labour contracts, where hospital owns the machinery and vendor deploys their labour and provide chemicals, in that scenario it is difficult to attain high annual turnover, which is a pre qualification requirement for this tender. Thus we propose following changes:

- Experience qualification to be revised to 2
 years instead of 5 years, we are right now
 serving in 3 reputed hospitals in Delhi,
 Namely
 - a. Maharaja Agrasen hospital 396 beds (1000 kg per day)
 - b. Action Balaji cancer hospital more than 500 beds (2000 kg per day)
 - c. Primus Super speciality hospital 120 beds (350 kg per day)

We are offering turnkey service including machinery, manpower, energy consumption, chemicals and complete maintenance. We are very experienced in this field and we can offer superior linen washing services with latest technology. Hence we propose following changes in the qualification criterion to be able to participate in the tender:

Further we would like to suggest amendments that <u>Joint Venture companies</u> shall be allowed to participate in bid because as per the PPP model most of the companies do not fulfil criteria of having required turnover and experience simultaneously because PPP model is not much established in Indian laundry segment that's the reason why most of the companies in India does not full fill such requirement. Or following financial qualification can be included as per railway norms:

C.1. Propose Barrier Laundry: As per our discussion we like to highlight and focus on the Barrier laundry concept as Hygiene is the most important aspect in the laundry cycle management from the wards to the laundry.

Hospitals and clinics have very strict hygiene regulations covering the handling and cleaning of linen, laundry, towels and staff clothing. This requires in-depth experience and special laundry solutions to guarantee safe, germ-free laundry and thereby protect patients.

Therefore we would like offer you complete laundry and linen cycle management proposal for the same for the best possible laundry operations in cost efficient and profitable way with best possible Hygiene Control.

C.2. Propose Minimum Guarantee

In the tender there is nothing mentioned about the volume of linen to be washed per day since the vendor will be investing huge amount on plant and machinery and will be deploying fixed manpower. thus a minimum load should be guaranteed by the hospital to recover fixed expenses. Since the hospital is new and will take months to achieve occupancy and thus generating sufficient linen load for the operator to recover the expense. Thus we request that total capacity of washing to be installed shall be mentioned in the tender and a minimum off take shall be guaranteed up to 75% of the installed capacity for the fixed charges, so that the contractor is able to recover his fixed expense during the period when the occupancy of the hospital is low.

Therefore we would like to propose that HSCC/Safdarjung should provide us minimum guarantee of soiled laundry to be washed on per day basis. For e.g. 2.5kg aprox. of laundry/bed*1300 beds=3250kg/day.

Further the same model is being adopted by Indian Railway for their boot laundry tenders. (Refer from South East Central Railway Bilaspur Division pg-42)

C.4. Responsibility of Service Provider

It has been mention in the tender that the service provider shall be responsible for collection of dirty linen from the different user areas within Super specialty Block & Emergency Block at Safdarjung Hospital and delivery the cleaned linen after laundry service.

Here we would like to highlight that the men power required for doing this services is not sufficient as mentioned in ANNEXURE-V (MINIMUM SUGGESTED MANPOWER to be located at

- 13. <u>STANDARD COMPANIES SERVICE PROVIDER:</u>
 The Companies which have some quality certification like ISO/ISI should be allowed to participate.
- 14. <u>AVAILABILITY OF SERVICES:</u> Tender is silent where the essential services like water and three phase Power will be provided in the laundry hall.
- 15. <u>STEAM BOILERS:-</u>It is recommended to use non-IBR boiler to avoid complicated requirements and operation of IBR boiler.
