Additionally, as per Form H attached in the NIT, specialized agency documents need to be submitted for the DG, HVAC, and Lift work. Therefore, it raises the question as to why the requirement for HVAC work experience is included in the contractor's scope in the minimum eligibility criteria.	Tender prevail.	condition	shall
2.	VolI (NIT)- Cl. No. 2.0. Minimum Eligibility Criteria, A "Work Experience", ii)	We would like to understand why the eligibility criteria specifically require contractors to have experience with a minimum of five storeys (G+4). Contractors who have successfully completed projects involving three or four storeys, or even a single-storey building, have to execute all the required building work items. We request revising the criteria to remove the "minimum five storeys" requirement and focus solely on "RCC framed structure." This revision would encourage wider participation from bidders, promoting a true spirit of competition and potentially resulting in more competitive rates.	Tender prevail.	condition	shall

Minimum Eligibility Criteria, A "Work Experience", ii)	We request allowing bidders to meet Firefighting work done criteria by engaging licensed specialized agencies for firefighting works and submitting Form H as proof of collaboration with such agencies. This approach would be more logical and ensure that qualified professionals handle this critical aspect of the project while enabling broader participation from general contractors.  Or  We request firefighting work completed by the bidder in other projects of equal or larger scale should be considered as fulfilling the requirement. This would ensure that qualified bidders who have managed significant firefighting work in other contexts are not excluded from participating.	Tender condition shall prevail.
