Request for extension of submission date of tenders will not be considered.

2. Late/delayed tenders : Late/delayed tenders due to any reason whatsoever will not be accepted / considered at all under any circumstances.

3. **Opening of Tenders:** The tenders received will be opened at **15.30 hrs** on **dated 18.04.2011** in the presence of the authorized representatives, if any, of the quoting firm (one member only) at this office. **Request for extension of opening date of tenders will not be considered.**

Quotation will also be opened on scheduled date and time even in case of nonpresence of any representative of the firms.

5. Payment will be made on monthly basis after submission of bills to the HRM Department.

6. The contract will be initially awarded for a period of three months on trial basis and on the basis of satisfactory services the contract will be continued upto one year from the date of award. However, HSCC reserves the right to cancel the contract without assigning any reason.

7. Deductions relating to TDS, and any other Govt. levies applicable on bills will be made as per Govt. of India instructions issued from time to time.

8. HSCC is neither responsible nor liable to pay any compensation for injury / death caused to the contractor's operating staff in the event of any accident on HSCC duty. Contractor will make his own arrangements to meet such eventualities as per existing Government rules/regulations.

The Contractor shall comply with all the laws, rules, and regulations applicable to him in respect of his staff and equipment and any breach thereof shall render the contract liable to cancellation.
