Condition:

1. The demolishing work must be completed in 45 days in all respects.

- 2. Earnest money Rs 5.00 Lac (Rs Five Lac only) in form of bank Draft drawn in favour of HSCC INDIA LTD. Payable at Noida/New Delhi should accompany the bid. Earnest money in any other from will not be accepted.
- 3. The bidder should quote rate in percentage above/below the reserve price mentioned in bill of quantities.
- 4. The bidder shall, within 7 days of receipt of the intimation of acceptance of his bid by HSCC pay to Director, Kalpana Chawla Govt. Medical College, Karnal (Haryana) by demand draft drawn in favour of "Director, Kalpana Chawla Govt. Medical College" Payable at Karnal, the full amount of the bid, where upon he shall take the possession of the building for demolition and give a receipt to the office of Director, Kalpana Chawla Govt. Medical College. No demolition shall take place before such payment is made and receipt given to the office of Director, Kalpana Chawla Govt. Medical College. In case the contractor fails to deposit the bid amount within 7 days, the earnest money shall stand forfeited.
- 5. Demolishing work shall be carried out manually and by mechanically means to ensure timely completion as per direction Engineer-in-charge.
- 6. In case the demolition work is not completed in all respects by the agency in 45 days, a penalty will be imposed @Rs.10000/- per day (subject to maximum amount of EMD) & shall be recovered from the earnest Money deposited.
- 7. Sale Tax and other taxes as applicable will be paid by the bidder separately alongwith the bid amount.
- 8. Full details of building to be demolished and the salvaged materials to be removed and disposed off is annexed at Annexure -I. The tenderer shall be deemed to have full knowledge thereof and shall have no claims on account of any shortage of materials etc.
- 9. The foundation shall be demolished down to required depth and site cleared, after filling the trenches with available earth upto the ground level.
- 10. The Bidder shall be responsible for any damage during the demolished operation and indemnify the HSCC/ Kalpana Chawla Govt. Medical College against any claim on account thereof including the third party and workmen's compensation claims. If damage is done to the said property or any other adjoining property, Director, Kalpana Chawla Govt. Medical College (Client) shall be entiled to have the same made good at the risk and cost of the bidder to treat default as a sufficient ground for terminating the contract and forfeiting the entire earnest money as well as the bid amount therefore.

- 11. The tenderer shall acquire no interest in the land bearing the said property except a license to enter thereon for demolition and removal of material and in particular shall not be materials, salvaged as a result of demolition and disposal thereof.
- 12. The premises shall be at the risk of the tenderer from the date of acceptance of the bid.
- 13. During demolition of building more that one floor, agency has to provide steel scaffolding and cover the building with sheets so that no debris etc should spill away. All workers will take proper safety measures like wearing helmet, safety shoes, safety belt etc when working.
- 14. If the tenderer fails to observe or perform any provision of the contract or become insolvent or make arrangement with creditor, the Engineer-in- charge may terminate the contract without notice prejudice to his right to claim any other loss there by incurred.
- 15. The conditional bids will be rejected out right.
- 16. HSCC./ Kalpana Chawla Govt. Medical College reserves in himself the authority to reject / or all the bids without assigning any reason therefore.
- 17. It may be made clear that no payment will be made by Director, Kalpana Chawla Govt. Medical College to the bidder for demolition and removal of the salvage material (including clearance of the site as per the instruction of the Engineer-in-charge) shall be taken into account by the bidder while quoting the amount to be paid to Kalpana Chawla Govt. Medical College for Entire Work.
- 18. Any material of historical value discovered below the ground level during demolition shall belong to and shall be property of Government of India.
- 19. If any dispute arises in connection with execution of the contract, the same shall be referred o Director, Kalpana Chawla Govt. Medical College and his decision shall be final and binding on both the parties.
- 20. The highest bidder will not be allowed to take away the wooden members, fiitings, fixtures & other serviceable material unless & until the site as cleared of all debris and is leveled with respect to ground level, to the satisfaction of Engineer-in-charge.
- 21. The bidder should sign every page of the bid form and amount to be paid in words and figures, both.
- 22. HSCC/Client reserves the right to restrict or to increase the no and areas of buildings to be dismantled. Payment on pro-rata basis shall be considered in case of any variation in quantity. No claim whatsoever will be on this account shall be entertained.
- 23. The bidders are advised in their own interest to visit the site before quoting rates.
- 24. The bidder should sign on all the pages of bid documents.
