2.	<p>Pertaining to SCC Clause 4A (iii) Indigenous manufacturers to quote themselves & not through any agent.</p> <p>Suggested Modification by the Bidder: To allow Authorized Representative of indigenous manufacturer to quote in this bid so that purchaser gets competitive pricing & there is saving to national exchequer.</p>	No Change. Existing tender conditions will prevail.
3.	<p>Pertaining SCC Clause 4A (iv):</p> <p>Tender Conditions: Section-III, Clause (iv) of Special conditions of contract (For Equipments):</p> <p>“Bidders should have in the past 5 years, satisfactory executed for the Item offered, at least one single order of like nature of item and quantity not less than 25% or two orders of 12.50% of quantity of the equipment as tendered against each items subject to a minimum of one quantity.
