- A minimum of 30,000 Multiple Choice Questions (MCQs) for objective assessments.
- These resources shall be made available to the students and faculty of Government Medical and Dental Colleges under the Medical Education Department, Government of Maharashtra.
- Majority of the resources provided shall be subscription based and not only open source and details of the same shall be provided.
