1.3 Tendering is open to all the agencies / firms having sound background and specialization in carrying out similar works.

2.0 PRE-QUALIFICATION CRITERIA:

- 2.1 Pre-Qualification will be based on meeting all the minimum criteria for prequalification and other qualification criteria regarding the Applicant's work experience, personnel and equipment capabilities and financial position as demonstrated by the Applicant's responses in the forms attached to the Letter of Application.
- 2.2 The Applicant should meet the following minimum criteria for Pre-Qualification:
 - (i) Average annual financial turnover during the last three consecutive financial years [2009-2010, 2010-2011, 2011-2012] should be at least 30% of the estimated cost.
 - (ii) Experience of having successfully completed similar work during last 7 years ending last day of month previous to the one in which tenders are invited should be either of the following:
