2.0 **Minimum Eligibility Criteria:**

The interested bidders should meet the following minimum qualifying criteria:

A. <u>Work Experience</u>:

- i) Joint-venture / consortia of firms / companies shall not be allowed and the bidder should meet the eligibility criteria themselves individually.
- ii) (I) Should have satisfactorily completed the following works in during Seven (7) years ending previous day of last date of submission of tenders:
 - a. Three *Similar completed works each costing not less than 40% of the estimated cost put to tender.

OR

b. Two *Similar completed works each costing not less than 60% of the estimated cost put to tender.

OR

c. One *Similar completed work costing not less than 80% of the estimated cost put to tender.

"*Similar Work" shall mean "Construction of Non-Industrial and Non-Residential multistoried RCC framed structure having minimum Five Storeys including finishing works, water supply, drainage & sanitary installations, electrical works, Firefighting, LV works, Lifts and HVAC all executed under one agreement". Airports, Metro Infrastructure & Power Projects shall not be considered.

NOTE:

- a) Mumty and Machine room shall not be counted as a storey.
- b) Each Basement, Stilt constructed in the building shall be considered as a storey.

AND

ii) (II) Additional qualifying criteria (either part of ii)(I) above or a separate one) :-

The bidder should have successfully completed one work consisting of a) & b) as mentioned below separately or collectively during the last 7 years ending previous day of last date of submission of tenders:

- a) Construction of RCC framed structure Hospital building/Composite Hospital Campus and allied services of Minimum 300 bed capacity with internal and external services including HVAC, Firefighting, STP etc. all composite executed under one contract on EPC mode/ turnkey basis.
- b) The bidder should have achieved an average monthly financial turnover/progress of at least Rs. 7.5 Crore per month in any single construction work costing not less than Rs. 160.00 Crore (in Hospital/Medical College project only) completed during last seven years ending previous day of last date of submission of tenders. The value of average monthly financial progress shall be worked out on the basis of completion cost of work divided by actual duration of work. The value of average monthly progress shall be brought to current costing level by enhancing the actual value of monthly turnover of single work @7% simple interest per annual calculated from date of completion of work to previous day of last date of submission of tenders. Projects have contract duration less than 12 months shall not be considered.

- iii) The past experience of similar nature of work should be in the name of the bidder and not in the name of associate company/ parent company/ group company/ subsidiary company etc. Past experience as part of a Joint Venture/Consortium/SPV (Special Purpose Vehicles) etc. shall also not be considered. Own works / work under the same management / own certification of the bidder shall not be considered for prequalification.
- iv) The past experience of similar nature of work should be supported by completion certificate(s) issued by the concerned organisation. In case the work experience is of Private sector, the completion certificate shall be supported with copies of Letter of Award, Agreement, Bill of Quantities, Certified Copy of Bills and copies of Corresponding TDS Certificates. Value of work will be considered commensurate with the value of TDS Certificates.
- v) The value of executed works shall be brought to the current level by enhancing the actual value of work done at a simple rate of 7% per annum, calculated from the date of completion to previous day of last day of submission of tenders.

vi) Foreign Certificate:

(a) In case the work experience is for the work executed outside India, the bidders have to submit the completion/experience certificate issued by the owner duly signed & stamped, and affidavit to the correctness of the completion/experience certificates. The EPC/Contractor shall also submit the completion/experience certificates attested by the Indian Embassy/Consulate/High Commission in the respective country along with the bid.

In the event of submission of completion /experience certificate by the Bidder in a language other than English, the English translation of the same shall be duly authenticated by Chamber of Commerce of the respective country and attested by the Indian Embassy/consulate/High Commission in the respective country.

(b) For the purpose of evaluation of Bidders, the conversion rate of such a currency into INR shall be the daily representative exchange rate published by the IMF as on 7(Seven) days prior to the Last Date of Submission of tender including extension(s) given if any.

In case of non-submission of above informations by bidders, the outside India work shall not be considered for prequalification.

B. Financial Strength:

- i) Turnover: Average annual financial turnover on construction works should be at least 50% of the estimated cost put to tender during the immediate last three consecutive financial years ending 31st March 2023. The requisite Turnover shall be duly certified by a Chartered Accountant with his Seal/ signatures and registration number.
- ii) The value of annual turnover figures shall be brought to the level of the last Financial Year FY-2022-23 by enhancing the actual turnover figures at a simple rate of 7% per annum.
- iii) The requisite Turnover shall be duly certified by a Chartered Accountant with his Seal/ signatures and registration number. Year in which no turnover is shown would

also be considered for working out the average. In case a Company/Firm is less than 3 years old, then the average turnover shall be calculated taking the turnover for the year for which no data is provided as zero.

- iv) <u>The bidders are required to upload and submit relevant pages of summarised</u> <u>Balance Sheet (Audited) for last three years ending 31st March 2023</u>.
- v) The turnover of the bidder on a standalone basis only shall be considered. The turnover of parent company/group company/subsidiaries or Consolidated Turnover shall not be considered.
- vi) **Profit/loss:** The bidder should not have incurred any loss (profit after tax should be positive) in more than two years during available last five consecutive financial years ending FY-2022-23. Balance sheet (balance sheet in case of private/public limited company means its standalone financial statement and consolidated financial statement both), duly audited by the Chartered Accountant.

The P&L Statement of parent company/group company/subsidiaries shall not be considered.

- vii) <u>The bidders are required to upload and submit relevant pages of summarised Profit &</u> Loss Account (Audited) for last five years ending 31st March 2023.
- viii) **Solvency Certificate:** Bank Solvency Certificate issued from Nationalised or any Schedule Bank should be at least 40% of Estimated Cost of the Project put to tender (ECPT). *The certificate should have been issued within 6 months from original last date of the submission of the tender*.
- ix) Net Worth of the company /firm as on last day of the preceding financial year i.e., FY-2022-23, should be positive.
- 3.0 The intending tenderer must read the terms and conditions of HSCC carefully. He should only submit his tender if he considers himself eligible and he is in possession of all the documents required. Information and Instructions for Tenderers posted on Website(s) shall form part of Tender Document.
- 4.0 Those intending tenderers/contractors not registered on the website <u>https://hscc.enivida.com</u> mentioned above with M/s RailTel are required to get registered beforehand. If needed they can be imparted training on online tendering process as per details available on the website i.e. <u>https://hscc.enivida.com</u>. The intending tenderer must have class-III digital signature to submit the tender.
- 5.0 The Tender Document as uploaded can be viewed and downloaded free of cost by anyone including intending tenderer. But the tender can only be submitted on the e-tender website after having digital signature by the bidder and after uploading all the requisite scanned documents.

- 7.0 The tenderers are required to quote strictly as per terms and conditions, specifications, standards and Design Basis Report & scope of works given in the tender documents and not to stipulate any deviations. The Bank Guarantee for EMD submitted by the bidders shall be strictly in the format prescribed in GCC. In case, EMD is not found verbatim in the prescribed format, the bid will be liable for rejection.
- 8.0 The bidders are advised in their own interest to submit their bid documents well in advance from last date/time of submission of bids so as to avoid problems which the bidders may face in submission at last moment /during rush hours.

However, after submission of the tender the tenderer can re-submit revised tender any number of times but before last time and date of submission of tender as notified.

- 9.0 When it is desired by HSCC to submit revised financial tender then it shall be mandatory to submit revised financial tender. If not submitted then the tender submitted earlier shall become invalid.
- 10.0 Contractor can upload documents in the form of PDF format.
- 11.0 Contractor is required to upload scanned copies of all the documents including valid GST registration certificate /EPF registration certificate/ ESIC registration certificate, PAN No. as stipulated in the tender document.
- 12.0 If the contractor is found ineligible after opening of tenders, or his tender is found invalid, cost of tender document and processing fee shall not be refunded.
- 13.0 Notwithstanding anything stated above, HSCC reserves the right to assess the capabilities and capacity of the tenderer to perform the contract, in public interest and the overall interest of HSCC. In case, tenderer's capabilities and capacities are not found satisfactory, HSCC reserves the right to reject the tender.
- 16.0 The tenderer(s) if required, may submit queries, if any, through E-mail and in writing to the tender inviting authority to seek clarifications within **3 days** from the date of uploading of Tender on website but latest by so as to reach HSCC office not less than 2 days prior to the date of Pre-bid meeting (if to be held as per NIT). HSCC will reply only those queries which are essentially required for submission of bids. HSCC will not reply the queries which are not considered fit like replies of which can be implied /found in the NIT/ Tender Documents or which are not relevant or in contravention to NIT/Tender Documents, queries received after 7 days from the date of uploading of Tender on website, request for extension of time for opening of technical bids, etc. Technical Bids are to be opened on the scheduled dates. Requests for Extension of opening of Technical Bids will not be entertained.

The Pre-Bid meeting shall be attended by the intending bidders only and not by vendors/manufacturers. Further, the intending bidders should depute their authorized person with authorization letter in original to attend the pre-bid meeting.

17.0 Integrity Pact (For all contracts valuing Rs.5.00 Crores and above)

17.1 Integrity Pact duly signed by the tenderer shall be submitted. Any tender without uploading pre-signed integrity Pact shall be liable for rejection.

17.2 Independent External Monitors

- (i) In respect of this project, the Independent External Monitors (IEMs) would be monitoring the bidding process and execution of contract to oversee implementation and effectiveness of the Integrity Pact Program.
- (ii) The Independent External Monitor(s) (IEMs) have been appointed by HSCC in terms of Integrity Pact (IP)-Section 7, which forms part of the tenders/Contracts. - (iv) The Independent External Monitors (IEMs) has the right to access without restriction to all Project documentations of the Employer including that provided by the Contractor. The Contractor will also grant the Monitor, upon his request and demonstration of a valid interest, unrestricted and unconditional access to his Project Documentations. The same is applicable to Subcontractors. The Monitor is under contractual obligation to treat the information and documents of the Bidder / Contractor / Sub-Contractors etc. with confidentiality.
