Terms and Conditions of Tender

- 1. The tenderer should quote their charges/rates clearly in the attached Format for Quotation. Cutting/overwriting, if any, should be countersigned by the tenderer. The rates quoted should remain firm and valid for one year. However, in case of variation in the rate of petrol/diesel by Rs(+ve or ve).1/-, the rate will be revised by (+ve or –ve)Rs.250/ for petrol driven and (+ve or –ve) Rs.175/ for diesel driven cars- for 2400/2100 KM. Variance will be calculated proportionately.
- 2. The tenderer should quote the rates both in figures as well as in words. In case of any discrepancy the rates quoted in words will prevail. The tenderer means an agency or individual having the required vehicles and interested to provide the same on rent to HSCC. The tenderer shall have the option to quote for all or any of the items in the Format for Quotation.
- 3. The bid validity shall be six months from the date of opening of the tender. The last date of submission of tender is upto 14:00 hrs. on 01.12.2014. The bids will be opened at 15:00 hours on the same day.
- 4. The earnest money deposit of Rs.5,000/- (Rupees Five Thousand Only) in the form of a Demand Draft/Pay Order drawn in favour of "HSCC (India) Ltd." payable at Noida/New Delhi should company the tender, failing which the tender shall be rejected. However, those participated in the previous tender of Oct-2014 need not to submit security deposit again. Performance Security will be forfeited for not reporting to duty within specified time after release of work order and will also be debarred from participating in future tenders.
- 5. The agency should inter alia furnish the following information/documents:
 - a. PAN & Service Tax Number
 - b. In case the Agency/Individual does not have PAN & Service Tax Number, they will have to enclose a DECLARATION that the PAN & STN will be submitted immediately after award.
- 6. Rates quoted shall remain firm for the entire contract period. No escalation on any account shall be admissible except as mentioned at sl no. 1 above and in case of increase/ decrease of statutory levies after submission of tender.
- 7. Sub-letting in any form is not permissible, otherwise the contract will be terminated immediately.
- 8. The tenderer should quote for a brand new vehicle of latest model having all the valid documents. The vehicle may be used for outstation duty also.
- 9. The driver running the car should have valid driving license and the vehicle should be registered with the concerned authorities. The driver of the vehicle provided must follow traffic rules & other regulations prescribed by the concerned authorities from time to time.
- 10. The drivers must observe all the etiquette and protocol while performing the duty. He must be neatly dressed and must carry a mobile in working condition, for which no separate payment shall be made by HSCC. The driver shall be bound to carry out the instructions of HSCC as well as the officers assigned to the vehicle.
- 11. The rates quoted by the agency should include monthly charges of driver, repairs, maintenance, insurance, fuel, oil and also any other incidental expenses in running and maintenance of the car. The rates quoted should include all taxes and levies, service tax etc. HSCC will only reimburse parking charges and toll tax against submission of documentary evidence on actual basis.
- 12. The engagement and employment of drivers and payment of wages to them as per existing provisions of various labour laws and regulations is the sole responsibility of the agency and any breach of such laws or regulations shall be deemed to be breach of this contract for which HSCC shall not be held responsible.
- 13. In case of any accident or any other contingency, any claim arising out of it shall be borne by the agency only and no claim whatsoever shall be borne by HSCC.

- 14. The vehicle shall be at the disposal of HSCC for all the days of the month (24x7)
- 15. If the vehicle is out of order, the agency shall provide a substitute vehicle immediately. In case, the vehicle does not report on time/does not report at all, HSCC will have the right to hire any other vehicle from the market and the additional cost incurred on the same will be borne by the agency and will be deducted from the bill/payments due to the agency.
- 16. The payment shall be made by HSCC after the end of every month on the presentation of the bill within next 10 working days. However, no interest is payable on delayed payments.
- 17. In case of non compliance of any of the clause/terms, HSCC will have the right to impose penalty as deemed fit. The decision of HSCC in this regard shall be final and binding.
- 18. HSCC and the agency both can terminate the contract by serving 90 days prior written notice.
- 19. Agency submitting the tender would deemed to have read and accepted all the terms and conditions.
- 20. HSCC reserves the right to accept or reject any or all tenders, without assigning any reason whatsoever.
- 21. In case of any clarification, the representative of the agency may visit the office with prior consent of the concerned HSCC officials.
- 22. Any act on the part of the agency to influence anybody in HSCC would make him liable for rejection of the tender.
- 23. Within 10 days of the date of notification, the successful bidder shall furnish performance security/security deposit for Rs.10,000/- (Rupees Ten Thousand Only) in the form of Demand Draft drawn in favour of HSCC (India) Ltd. payable at Noida or New Delhi from a Nationalized/1st Class/Scheduled Bank.
- 24. In case of dispute arising out of this contract, the said dispute shall be referred to the sole Arbitrator appointed by HSCC and the provisions of Arbitration & Conciliation of India Act, 1996 will apply.
- 25. Dedicated vehicles must be provided. The successful bidder shall provide vehicles within 15 days from the date of award.
- 26. The successful bidder shall have to provide the desired number of vehicles. However, in case the successful bidder fails or expresses his inability to provide the total no. of vehicles required, the option shall be given to other bidders to provide remaining number of vehicles at the lowest quoted rate.
- 27. In case the agency withdraws or HSCC terminates the contract for violation of terms & conditions/deficiency in service during the period of contract, the performance security shall be forfeited.
- 28. Failure by the agency to comply with any statutory requirement and/or the terms of the agreement during the period of contract shall result in termination of the contract and subsequent disqualification from participation in future tenders of HSCC.
- 29. The driver may have to put minimum12 hours duty and the duty hours may vary depending on exigencies, however, there will not be any change in the rates or extra rates and also they should not have any reservations for going on outstation duty.
- 30. The contract may initially be for a period of one year and can be extended further on mutual consent.
- 31. Lowest bidder (L1) will be determined on the basis of rates quoted in all inclusive column against each vehicle independently. In case the agency backs-out after the award, the EMD will be forfeited and tenderer shall be debarred for future tenders in HSCC. In that case L2 will be awarded the contract for providing the vehicles.
- 32. The rate per car should be specified (inclusive of all taxes and duties) for 2400/2100 km and 315 hours on monthly basis (reckoned from the time of reporting to the time of release). The charges for additional hours after 315 hours and additional distance beyond 2400/2100 kms per month should also be clearly specified.
- 33. The vehicle will be parked at the HSCC office / designated place/ residence of the official using it. The agency has to ensure that the vehicle is regularly serviced and maintenance is done as per manufacturer's recommendation.

- 34. In case the driver does not report for duty replacement will be provided immediately. In the event the driver is found unsuitable, misbehaving, not found experienced enough to drive, found ever consuming liquor on duty, stealing any item, regularly not reporting duty on time, not aware of and breaking traffic rules he will be asked to replaced immediately.
- 35. The driver shall maintain the log book (to be provided by HSCC) with signature of designate user on daily basis.
- 36. This office will not bear the cost of any dead mileage expenses. The mileage shall be calculated from the place of designated parking and so would be the timings. Any usage (mileage) and hours less than the specified monthly limit will be carried forward to the succeeding month for usage and adjustment. Similarly mileage and hours over and above the specified monthly limit will be carried forward for payment and adjustment. However, the payment for the mileage and hours over and above the monthly specified limit, if any, will be considered at the end of the contract in final bill.
- 37. Bids once submitted shall not be allowed to be withdrawn and any default after acceptance of the bid shall be deemed to be non-compliance of terms of contract and would be liable to forfeiture of EMD.
- 38. HSCC has the discretion of using the driver provided by the party or its own driver. The rates paid to the agency will based on the provision /non provision of driver by the agency.
- 39. This tender/contract shall be subject to the exclusive jurisdiction of Delhi Courts only.
